A RESOLUTION OF THE BOARD OF SUPERVISORS OF BRECKNOCK TOWNSHIP, LANCASTER COUNTY, PENNSYLVANIA, ESTABLISHING THE FEE SCHEDULE FOR SUBDIVISION AND LAND DEVELOPMENT APPLICATIONS

WHEREAS, section 503 of the Pennsylvania Municipalities Planning Code, 53 P.S. 10503, authorizes municipalities to charge fees for the filing and processing of Subdivision and Lands Development applications;

WHEREAS, the Brecknock Township Subdivision and Land Development Ordinance of 2013 authorizes the Board of Supervisors, by resolution, to adopt a fee schedule to reimburse the Township for various costs associated with the filing and processing of Subdivision and Land Development Plans;

WHEREAS, it is the desire of the Board of Supervisors of Brecknock Township to establish a fee schedule for the filing and processing of Land Development Plans, Subdivision Plans and Lot Add-On Plans.

NOW, THEREFORE, it is hereby resolved by the Board of Supervisors of Brecknock Township, Lancaster County, Pennsylvania, that the attached fee schedule for filing fees for Subdivision Plans, Land Development Plans and Lot Add-on plans submitted to the Township are established and become effective on April 9, 2013.

It is also resolved that: 1) the filing fees for Subdivision Plans, Land Development Plans and Lot Add-On Plans shall be paid when the applications are submitted to the Township. Applications shall not be considered complete and will not be accepted until the filing fees are paid. 2) Applicants shall be responsible for paying for the township's engineering and consultant expenses associated with the review of subdivision and land development plans.
