## Brecknock Township Board of Supervisors Meeting September 13, 2022

The regular meeting of the Brecknock Township Board of Supervisors, Lancaster County that was scheduled for September 13, 2022, was held at the Brecknock Township Building, 1026 Dry Tavern Road, Fivepointville. The meeting was called to order by Chairman Jerry Long at 7:00 p.m.

There was a discussion regarding what the possibility of the orchard hooking up to the public sewer even though they are currently outside the sewer service area. They were at the Northern Lancaster County Authority meeting prior to attending this Board meeting looking for a general feeling from them as well. After a lot of discussion it was left with the township engineer would reach out to the Northern Lancaster County Authority engineer to see what the current capacity would be if the current Act 537 plan was completely built out, would there be room for the orchard and what the Northern Lancaster County Authority status is on a feasibility study/rerate of the plant is.
