The regular meeting of the Brecknock Township Board of Supervisors, Lancaster County that was scheduled for June 14, 2022, was held at the Brecknock Township Building, 1026 Dry Tavern Road, Fivepointville. The meeting was called to order by Chairman Jerry Long at 7:00 p.m.

At this time, the Pledge of Allegiance took place.

Present were Board of Supervisors Jerry Long, Andrew Baum & Secretary/Treasurer Carol Martin. Dave Leinbach was absent.

Michael Reinert, Township Engineer, and Elizabeth Magovern were both present as well.

Community Open Session – Hearing none the meeting continued.

A motion was made by Baum and seconded by Long to approve the minutes of the May 10, 2022; Board of Supervisors Meeting as presented. All in favor, motion approved.

A motion was made by Baum and seconded by Long to approve the bills as presented. All in favor, motion was approved.

Roadmasters Report – Discussion for Slabach Rd and Chestnut Hill Culvert will be tabled till next month when there will be a full board in attendance.

Martin Church Rd. There is a stream restoration being done with Lancaster County Conservation District and Fish & Boat along the Muddy Creek at Ammon Martin's property (Red Run). Where the Muddy Creek makes a hard bend at Martin Church Rd the bank is eroding. Laverne Brubacher who is the excavator doing the work for the Conservation District asked if the township wants them to stabilize the bank in our township while he is there doing the other work. The Lancaster County Conservation District would have the work done in our township if we would be willing to contribute to the project. After some discussion, a motion was made by Long and seconded by Baum to authorize a donation of \$2500.00 toward the project. All in favor, motion approved.

At this time Andy brought the Board up to speed on the current pricing situation for a new John Deere Backhoe, which is due to be replaced in 2023.

The board reviewed the items that needed action on Michael Reinert's Engineers report and presented by Mr. Reinert.

All in favor, motion approved.

Motion was made by Baum and seconded by Long to adopt Resolution 2022-13 a RESOLUTION APPROVING AND AUTHORIZING PARTICATING MEMBERS OF THE FIRE COMPANY TO PARTICIPATE IN CERTAIN OPERATIONAL SUPPORT ACTIVITIES.... All in favor, motion approved.

Motion was made by Baum and seconded by Long to authorize the list of activities presented to the Board for the calendar year of 2022 for the Fivepointville Ambulance Service. All in favor, motion approved.

A motion was made by Baum and seconded by Long to adjourn at 7:48 pm. All in favor, motion approved.
